<u>Treasurers Report on the Unaudited Accounts</u> <u>of Nagarhope (Ireland)</u>

The Income and Expenditure Account for the period ended 30th April 2020 and the Balance Sheet as at 30th April 2020 are presented in the following pages. This meets the current financial reporting requirements under relevant law and regulations. The Charities Act (2009) provides that where the gross income or expenditure of a charitable organisation in a financial year does not exceed €100,000, the charity trustees may, instead of preparing an annual statement of accounts in respect of that year, prepare an income and expenditure account in respect of, and a statement of the assets and liabilities of, the charitable organisation. Accordingly, Nagarhope (Ireland) is not required to prepare formal audited accounts.

There are new Accounting and Reporting Regulations due to come into effect for registered Charities in Ireland. A review of these regulations will be undertaken to ensure our financial reporting continues to comply with all applicable regulations.
